This letter is to advise you that we have been able to resolve the litigation over the sale of the Valley Junction Lodge on the terms we sought when we first filed suit.

The litigation began in January of 2012 after we had determined that the Valley Junction Lodge had distributed \$240,000 from the sale of their Lodge building, and another \$30,000 the Lodge had in CD's, to five of their members, Kathy Green, Joe Hull, Beryl Hull, Frank Perez, and Louella Speck, and also to a non member of Valley Junction Lodge, Allen Green. At the time we filed suit, after involving the F.B.I., we had already been able to recover \$180,000 in funds, including all of the funds taken by Kathy and Allen Green. After we filed suit Kathy Green brought counterclaims that included a wide variety of allegations including defamation, intentional infliction of emotional distress, wrongful discharge, and racketeering on the part of not just the Grand Lodge, but a wide variety of other individuals as well as the Sovereign Grand Lodge.

Throughout the litigation our intent was to recover the entirety of the \$270,000 in funds, and to also get a dismissal of all of Ms. Green's counterclaims on the grounds that they were baseless and without merit. During the litigation, meanwhile, both Frank Perez and Louella Speck stepped forward to pay the remaining funds they had received, but not yet returned, leaving only \$45,000 still in the hands of Joe Hull and Beryl Hull. We were able to settle the matter at this time, without spending the \$150,000 it would likely have taken us to take the case through trial, because Joe and Beryl Hull finally entered into an agreement and payment plan to return the remaining \$45,000 in lodge funds that had been distributed to them, and Kathy Green agreed to dismiss all of her claims. Jim Jones, Beryl Hull, Joe Hull, Allan Green, and Kathy Green have all resigned from the Order and/or have agreed to never re-apply or seek reinstatement.

The decision to settle the case was a difficult one as we had aggressively pursued our claims, and defended against those of Kathy Green, in the litigation. As a result of this effort, and the underlying facts we were able to establish through multiple affidavits and deposition testimony, our attorneys were confident we would prevail in all matters at trial. This accordingly provided significant incentive to take the matter to trial and have a jury vindicate us on all counts. What none of us had confidence in, having secured and reviewed multiple bank account records from various defendants, was that we would actually be able to recover on any monetary judgment, either for the remaining \$45,000 or for the award of punitive damages we were pursuing. This is because the only apparent remaining assets of the Defendants at this time are retirement accounts and homesteads which are "exempt" in Iowa from collection on a judgment, meaning then Lodge

even if a jury awarded us punitive damages in addition to the remaining \$45,000, we would not have been able to collect on them. Further, we likely would have been forced to expend another \$150,000 or so in the remaining preparation for, and in litigating, what was projected to be a two week trial involving ten different parties.

Regardless of the fact that settling the trial was, from a fiduciary standpoint, clearly the right decision, it was nevertheless a difficult decision because of all the baseless accusations that had been made and because of all the work expended in the litigation to date. There are likely some who were involved in the litigation to this day who believe we should have taken the matter to trial. Yet, as a charitable fraternal organization, preserving the \$150,000 for benevolent purposes, as intended when the money was raised by our members, was clearly the right thing to do once we secured an agreement for the repayment of the remaining \$45,000 and the dismissal of all of Ms. Green's counterclaims. Our attorneys, meanwhile, assured us that we need not pursue the case to establish any precedent because the Iowa Supreme Court has specifically recognized the reversionary interest of the Grand Lodge and that all local lodges, and all members of the Order, are bound to a solemn and enforceable trust to hold the property and funds of the Odd Fellows for the good of the Order, and that Constitutional provisions and internal rules regarding such property and funds are fully enforceable in state court where that trust is violated.

Hopefully, going forward, we will not need to re-enter any new litigation and all members of our Order will respect our Constitution and Bylaws and will act in the capacity which our Constitution, and the laws of Iowa, require. The matter with the Valley Junction Lodge has, however, also taught us that despite the best hopes and intentions, the Grand Lodge needs to be prepared to act quickly with resort to both law enforcement and the courts when a Lodge or members violate their solemn obligations to the Order.

For now, however, it is with relief that we can stop spending the funds of the Order on litigation to establish the rights of the Order, and hope that we need not engage in such acts in the future, that we are sending you this letter to inform you that the matter with the Valley Junction Lodge has been fully resolved.
